



Focal Point of Resolution 18

**RELEVANT PROPOSALS ON RESOLUTION 18**

Principles and procedures for the allocation of work to, and strengthening coordination and cooperation among, the ITU Radiocommunication, ITU Telecommunication Standardization and ITU Telecommunication Development Sectors

A study of all regional proposals indicates that most of the proposals are similar among all the regional positions as summarised below:

1. All agree to retain the same title and most of the Resolution, except as below:
2. CITEL, ATU and RCC all propose deletion of all of *considering c)* but keep reference to Constitution and convention. In our draft common proposal, we had further strengthened this and moved it to *recalling* but it seems the intent is similar. We should continue with our proposal.
3. In CITEL proposals under *considering b)* they have deleted the list of issues of concern and replaced it with a reference to Resolution 191 while RCC and ATU and APT retain the list of concerns in the resolution. In APT, we had also added AI to the list of issues of concern. Need further discussions
4. Proposals under *considering d)* about reference to joint meetings is proposed to be replaced by Inter sector Coordination Group (ISCG) which has proved to be effective. We could adopt this. In CITEL the reference to the joint meetings is shown as a new “*taking into account*”
5. all proposals delete the whole existing section *taking into account*. We may consider doing the same
6. Under *Resolves 1)* CITEL proposes to change the responsibility for coordination from Joint meeting to TSAG. We can further consider this.
7. Under *Resolves 2) ii* , CITEL, ATU as well as RCC have proposed matching/merging of relevant question topics of interests to the study groups. This would need some further discussions
8. CITEL has proposed a new “*Invites member states and sector members*” to support coordination efforts. This is a good proposal, and we could adopt the same.

It is proposed as well to acknowledge the coordination performed by ISCG, as noted in Resolution 191 (Rev. Dubai, 2018) of the Plenipotentiary Conference, including as a locus for the three advisory groups to discuss matters that need coordination.
