
Highlights of the week:



ITU-R's 1st Inter-regional Workshop on WRC-23 Preparations are starting from 13th to 15th December. IAFI delegates under the leadership of Mr. Bharat Bhatia, will be participating in this event.

ITU-APT Foundation of India (IAFI) has drafted appropriate responses to the Consultation Paper by Telecom Regulatory Authority of India (TRAI) on "Licensing Framework for Establishing Satellite Earth Station Gateway" and invited written comments on the issues raised in the Consultation Paper (CP). Comments have been accepted from various stakeholders. IAFI made the necessary changes after hosting a meeting to finalise the CP. Last date for the submission of the response is 13th December 2021.





ITU-APT Foundation of India (IAFI) has been drafting appropriate responses to the Consultation Paper by Telecom Regulatory Authority of India (TRAI) on Auction of Spectrum in frequency bands identified for IMT/5G. Comments have been invited from various stake holders by the 28th of December, based on the comments received final response will be submitted to TRAI before the last day of submission is on 11th January.

Mr. Tilak Raj Dua, Chairman IAFI participated in the IMC 2021 organised by COAI and DOT. He spoke on Gati Shakti for Digital Infrastructure - Strengthening the backbone of connectivity which talks about essentially creating a digital platform to bring 16 Ministries including Railways and Roadways together for integrated planning and coordinated implementation of infrastructure connectivity projects. It will facilitate the last mile connectivity of infrastructure and also reduce travel time for people.



The Telecom Regulatory Authority of India has requested Starlink, the satellite tv for pc broadband arm of Elon Musk's SpaceX, to not "solicit any telecom business or collect any related fees" for its upcoming broadband-from-space companies in India without the mandatory authorisations. The order comes simply over per week after the communications ministry barred Starlink from looking for pre-bookings for its internet-from-space

Telecom regulatory authority of India (TRAI) on Tuesday directed all teleos to "immediately" enable port out SMS facility for all subscribers requiring it, irrespective of value of their tariff offer, vouchers, or plans. The sector regulator noted that in the recent past, it has received complaints from subscribers over their inability to send SMS on short code 1900 specified for UPC (Unique Porting Code) generation, for availing mobile number portability facility despite having sufficient balance in their prepaid accounts.
