Telecom Stories:



Telecommunications Engineering Centre (TEC), Department of Telecommunication (DOT) has invited the public comments on adoption of TSDSI transposed Standards Radio Interface Technology (named 5Gi) towards IMT 2020 into National Standards by Telecommunications Engineering Centre (TEC). Standardisation Guide" – a policy document for adoption of telecom and related ICT standards defines the process of adoption/ratification of TSDSI/international standards like institutional mechanism, process

of adoption, maintenance of standards, numbering plan, stakeholder consultation etc. The last date for seeking the comments have, now, been extended up to 15th August 2021.

Shri. Ashwini Vaishnaw ji welcomed Intel to India after Intel Foundry Services president Dr. Randhir Thakur congratulated the minister over the central government's decision on design and manufacturing of semiconductors chips in India.





The Department of Telecommunication is considering using "street furniture" to densely deploy next generation or 5G telecom infrastructure to overcome right-of-way (RoW) challenges following a proposal from a state electricity board. "The support from state governments is critical, and the department is considering a serious enhancement of RoW policy otherwise the spectrum auction and its allocation may not yield desired benefits.
