Highlights of the week:

ITU-T- SG3 - Tariff and accounting principles and

international telecommunication/ICT economic and policy issues: The meeting began on 1st of March 2023 and will conclude on 10th of March 2023. DOT and IAFI have jointly submitted a contribution on the creation of Focus Group (FG) on costing models for affordable data services. This contribution will be discussed in this meeting with a view to approve the creation of the new FG. IAFI along with the other members from DOT are actively participating in this meeting.



<u>16th Executive Council meeting:</u> The 16th EC meeting of IAFI took place on Tuesday, 28th February 2023 at 12:30 PM at the IAFI office with remote participation. The meeting reviewed both past events and current activities of IAFI. The EC also approved 2 new corporate members i.e., Amazon and Conqueror Innovations respectively.
