Highlights of the week:

43rd Working Party 5D: 43rd 5D which is responsible for the overall radio system aspects of IMT (4G, 5G and 6G) began on the 31st of Jan and concluded on 9th February. 4 contributions have been submitted by IAFI on IMT multimedia, IMT Applications and FSS band frequency, IMT Vision 2030. Many IAFI members have been registered as delegates for the meetings and are actively participating in these meetings. All 4 contributions of IAFI have been successfully presented and accepted.

<u>IAFI meeting with ITU deputy Secretary General:</u> Mr. Bharat Bhatia (President, IAFI) met with ITU Deputy Secretary General and discussed for our regular contributions in almost every meeting of ITU Groups and discussed collaboration on industrial 5G, sustainable development, CTUC, enhanced participation of the Industry in ITU activities through fellowships to attend ITU meetings, etc.

Telecom Stories:

The Centre is likely to invite a "second round" of applications for semiconductor chip manufacturing in the country under the \$10 billion incentive package. The second round of applications is expected to open as early as mid-March. Last year, India had accepted five proposals for the scheme with the application window having closed in February 2022.

The Department of Telecommunications (DoT) and the Directorate General of Civil Aviation (DGCA) have formed a joint committee to look into ways to safely deploy next generation (5G) telecom towers across India's 137 airports. The deployment of fifth generation (5G) networks alongside airports has become a contentious issue between the two government departments who are in a deadlock since last year.

The Union Minister of State and Information Technology dispelled rumours about how social media networks operate in India. The centre, according to Rajeev Chandrashekar, has no plans to regulate social media intermediaries. The IT rules 2021, according to the Union Minister in a written response to the Lok Sabha, define specific obligations in the intermediaries nor does it impose any restrictions on users' freedom of expression.
